



La Lechonera #WFCGrillsWithMojo Online Recipe Contest Official Rules

1. HOW TO ENTER:

To enter in the online recipe contest:

- A. Create an original recipe(s) prepared on a grill (outdoor standard grill or indoor griddle) using La Lechonera's Natural Mojo Criollo. Multiple recipe entries are permitted.
- B. Submit the full recipe(s) and a photo(s) of the dish through the contest link (here).

To enter in the additional People's Choice component (OPTIONAL):

- A. Post your La Lechonera Natural Mojo Criollo grilled recipe entry onto your public Instagram account
- B. Include hashtags: #WFCGrillsWithMojo and #Contest
- C. Tag WFC (<u>@worldfoodchampionships</u>) and La Lechonera (<u>@mojolechonera</u>)

Entries will be accepted during the dates of the contests: September 4-14, 2020. The contest sponsor (La Lechonera) is offering free product (3 liters of its Natural Mojo Criollo) and shipping to participants. In order to take advantage of this offer, participants must complete this form (here) by 11:59pm CDT on August 7, 2020. Contest participants are not required to receive free product and shipping in order to compete in the contest.

No mechanically reproduced, facsimile or photocopied entries allowed. WFC is not responsible for lost, late, damaged, misdirected, illegible or incomplete entries, all of which are void. Entries become property of WFC and La Lechonera Products and will not be returned.

2. **ELIGIBILITY:** This contest is open to anyone globally, excluding employees of WFC, its respective parent companies, subsidiaries, affiliates, related companies and advertising and promotion agencies, and the families and/or household members of each of the above. All entries must be an original creation, not duplicated or copied.

3. JUDGING:

- A. Online Recipe Contest: Winners are chosen from all eligible entries received and will officially be announced on the <u>WFC's Facebook Page</u> on September 27, 2020. Judging will be conducted by no more than three (3) members of WFC's Ambassador Council, whose decisions are final on all matters relating to this contest. Winners do not need to be present to win. Winners will be notified within eight (8) business days after the designated contest period ends.
- B. People's Choice: The People's Choice entry with the most overall likes will be declared the winner. Winner will officially be announced on the <u>WFC's Facebook Page</u> on September 26, 2020.





4. PRIZES:

- A. Online Recipe Contest: There will be (2) two WFC Golden Ticket winners through the online recipe contest. The winners will be eligible to enter into the category that best coincides with the winning dish. (Example: If a participant wins with a soup, he/she will enter into the 2021 World Soup Championship).
 - The First Place winner will receive a waived entry fee Golden Ticket into WFC 2021. Approximate Retail Value of First Place Prize: **\$300**. The Second Place winner will receive a qualification-only Golden Ticket to attend and compete at WFC 2021, but an entry fee of \$300 will be required. Odds of winning depend on the number of eligible entries received. **Participants may enter multiple entries.** Limit one prize per person.
- B. The People's Choice winner will receive a qualification-only Golden Ticket to attend and compete at WFC 2021. In addition, the People's Choice winner will also receive a gift box of BBQ merchandise, provided by La Lechonera. Retail Value of the BBQ merchandise: \$XXX.
